


Prevas GCM (Goods Certificate Manager) – system for electronic article information

Prevas GCM is a web based system where distributors register, maintain, and send trade item information electronically to buyers in FMCG. Prevas GCM supports GS1's latest standard for trade item information in GS1 XML-format and includes a food and beverage extension, is easy to get started with and the service also includes support with experienced staff.







WHAT IS PREVAS GCM?

- GCM is a web based system where distributors register, maintain, and send trade item information electronically to buyers in FMCG, Apoteket AB, and to other pharmacy chains. GS1's webservice Validoo Item is used when sending trade item information to buyers.
- GCM supports GS1's latest standard for trade item information in GS1 XML-format and includes a Food and Beverage Extension. The Food and Beverage Extension contains registered detailed information for consumable products for retail businesses, restaurants and mass caterers.
- GCM electronic trade item information can be sent to all buyers connected to GS1 Validoo. There is also the possibility to send trade item information to other countries via GS1's network (GDSN).

ADVANTAGES WITH PREVAS' GCM

- Web based service where Prevas is responsible for the operation, security, and maintenance. No installation is required, since all that is needed is a PC with access to the internet
- Easy to get started with. Can, if needed, be integratedwith the distributors ERP system.
- Functions are included for validating data as for example control of mandatory fields, function for copying existing trade item information and possibility to give user different user rights in the system.
- Fixed monthly fee with unlimited number of users.
- Support is included.
- If needed, existing trade item information can be imported via (but not limited to) XML, Excel-files, or from the distributor's database.
- Existing trade item information in Prevas GCM can be exported to Excel- or Pdf-file.
